She opened a lemonade stand on her lawn and all the monies would go toward cancer research. Her parents, Liz and Jay Scott, have carried on Alex's legacy, devoting their lives to raising awareness and funds for cancer research.

The telethon kicks off the **5th annual ALSF Lemonade Days**, a 3-day national event where volunteers host lemonade stands throughout the Country, all raising monies to fight pediatric cancer and to fund new research

studies. Last year, during Lemonade Days, more than 1500 lemonade stands raised over \$1 million toward Alex's efforts.
