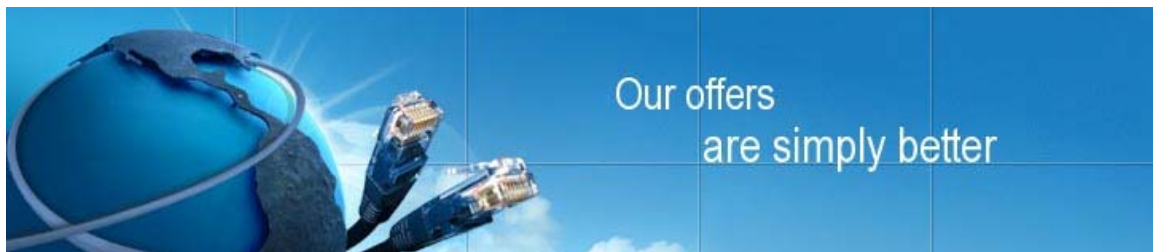

The acquisition will close as soon upon final review by counsel of **Physicians Remote** and the shareholders of **Valtech** of the draft acquisitions agreement.

Pursuant to the letter of intent, **Valtech** shareholders will receive an aggregate of 40 million shares of **Physicians Remote's** common stock.

Communications Valtech owns and operates a triple play (telephone, internet and TV channels distribution) network in Canada via fiber. It presently offers its fast growing retail customer base IP telephony, internet bandwidth in 10 Mbps increments and 83 television channels all based on IP of broadcast quality. **Valtech** also services hotel and retirements homes by offering bulk long term agreements to its commercial customers.

Valtech has chosen **Ericsson's (NASDAQ:ERIC)** IPTV solution as part of the expansion of its technology base..
